Eligibility

Business owner experienced decreased sales of 1 of the months this year by more than 50% compared to the same month last year, due to COVID-19

The maximum amount of benefits is the amount of decrease from sales last year

Support fund for elementary school closure

Shogakkou Kyuugyotou Taiou Shienkin



Days between February 27 to June 30 where you could not perform contracted work
4,100 yen per day (fixed amount)

Eligibility

Guardians who could not perform contracted work to care for children during temporary school closure

Works contracted before closure of schools are covered

Subsidy for introduction of IT (special category)

IT Donyuu Hojokin



Subsidy rate 2/3
Amount 300,000 to 4.5 million yen

Eligibility

Businesses that have installed work efficiency tools to begin working from home

Rental costs for PCs and tablets are also acceptable

Employment Adjustment Grants (special measure)

Koyou Chousei Joseikin (Tokubetsusochi)



Subsidize a part of paid leave allowances (will be expanded to 100%) (up to 8,330 yen per person per day)

Eligibility

Employer who have paid leave allowance to workers (including part-time work) due to COVID-19

Special measure period is from April 1 to June 30

Subsidy for elementary school closure

Shogakkou Kyuugyotou Taio Joseikin



Subsidize wages paid to workers who use paid leave (up to ¥ 8,330 per day)

Working place of guardians who took leave to care for children during temporary school closure

Covered period is February 27 to June 30

Subsidy for sustaining business (special category)

Subsidy rate 2/3

Eligibility

Small businesses that are switching to non-face-to-face services such as online sales because of COVID-19

Equipment/system investment for the above is required

Stoppage of school, individual business, etc.
Within 200,000 yen
In other cases

Social Welfare Councils (Labour Banks in addition)

Eligibility

People affected by COVID-19 and need to maintain their livelihoods with reduced income

No interest/no warranty required/1 year deferment/2 years repayment

Various loans for financial support

Shikingurishien no Kakushu Yuuushi



Loans with no guarantee fee / interest and deferred repayment period are available. Type of loan and contact will depend on the extent of decrease in sales.

Eligibility

Business owners with difficulties in finance due to the decrease in sales affected by COVID-19

Japan Finance Corporation, Shoko Chukin Bank, private sector, etc.

Tax related support measures
